The CPO is trained in the most advanced techniques in safety, water chemistry, maintenance, and management.

The rapid advance in know-how and technology of pool operation require constant updating skills. With over 7.5 million pools in use, the need for qualified operators is greater than ever. And the need will continue to grow. Certified Pool Operators must keep the facility in good operational order and maintain the equipment. Only an individual with suitable training and experience is qualified to meet such responsibilities.

With the adoption of the proposed Wisconsin Department of Health Regulations, the PHTA CPO will be the required level of training.
